This article shows each state's prescription drug monitoring program (PDMP) availability.

Recent Changes to PDMP Funding (2024)

- May 6, 2024: State Funding is Now Available for Wyoming**
Wyoming has approved funding for Gateway + Basic Report PDMP integrations. As of 5/1/2024, all partner and client WY integrations were switched to funded status within Bamboo Health’s system. There is nothing our partners and clients need to do unless they wish to upgrade to the NarxCare enhanced report.
- January 25, 2024: Utah PDMP Integration is Now Available**
Utah is non-state funded and requires NarxCare for all integrations (client must pay for the advanced NarxCare report).

Note: With the exception of California, Maryland, and Wisconsin average time to process PDMP is highly variable by state, depending on state processes. The chart below captures average time to process PDMP based on historical data. However, these times may not necessarily be an indicator of present or future times to process PDMP by state.
